
9. INVESTMENT AND UTILIZATION OF FUNDS:

It is clarified that the power of investment of the Trust funds including those mentioned in Clause 6(iv) shall be exercised in accordance with the provisions of Section 13 of the Income Tax Act 1961 in general and in particular shall not violate the provisions of Sections 13(1)(d) read with Section 13 (5) of the Act so as to ensure exemption under the Act.

They may, however, reimburse themselves and pay and discharge out of the trust property all costs, charges and expenses bonafidely incurred by them; incurred in or above a promotion or execution of the objects of the Trust. Any of the Trustee renders services independently, he being Trustee of the Trust, on full time basis, shall be entitled for remuneration and benefits as equal to any other employee of the Trust.

- 10.2 INDEMNITY: The Trustees shall be kept fully indemnified and harmless by the Trust against any claim, demand on liability arising against them for anything done by them and the trustee/s shall be liable for any loss caused to the Trust by any act of thing committed or done by such Trustee/s, if the Trustee/s was/were acting in good faith and in proper discharge of his/their duties towards the Trust.
- 10.3A Trustee shall be deemed to have been discharged and his office shall become vacant on the happening of all or any of the following events:

- b. If he/she is adjudicated or if he/she applies to be so adjudicated.

The Trustees shall be deemed to have been discharged and his/her office shall become vacant if the remaining Trustees at a formal meeting pass a resolution by majority (which resolution shall not be opened to question) declaring that the said Trustee has acted in a manner prejudicial to the interest of the Trust or his/her continuance as a Trustee is considered otherwise undesirable.

The Vice Chairman shall assist the Chairman in the formulation of the schemes and activities and shall preside over the meetings of the Board in the absence of the Chairman.

11.3 SECRETARY:

The Secretary shall be the principal executive officer of the Trust and shall execute all the decisions and resolutions passed by the Board in the right earnest. He shall at all times keep the Chairman and the Vice Chairman informed of all the important developments and other activities of the Trust. The Board of Trustees shall authorize the Secretary to sign, execute and register important legal documents, relating to the educational institutions of the Trust with the consent of the Chairman.


12. MEETING AND BUSINESS TRANSACTIONS BY THE TRUSTEES:






