- Vide reference cited (3), proposals were sent to the Government requesting to delegate the powers to the Fire Prevention Wing of the Municipal Corporations to scrutinize the plans and to conduct inspections and periodic safety audit of certain hazardous premises to ensure Fire safety compliant to the National Building Code of India, 2005.
- 3) (a) Vide reference cited (4), Government has informed that under Section 13 of the A.P. Fire Service Act, 1999, the No Objection Certificate from the Director General, A.P. State Disaster Response and Fire Services, Hyderabad or any authorized officer by her is required for the purpose construction of building of more than 15 Meters height for commercial/business purpose 18 Meters and above height for residential purpose etc. In respect of other buildings, it is not necessary to obtain No Objection Certificate and the Fire Prevention Wing of the Municipal Corporations shall scrutinize the plans of these buildings and conduct inspection etc., to ensure fire safety compliance and submit its report to the Municipal Corporation/HUDA for the purpose of issuing notices to the owners for occupiers for compliance with fire service requirements.

- The MA & UD Department has requested Home Department to issue necessary instructions to the DG (Fire), to delegate the following powers to the respective Corporation viz. (i) Greater Hyderabad Municipal Corporation; (ii) Greater Visakhapatnam Municipal Corporation; (iii) Vijayawada Municipal Corporation; (iv) Tirupathi Municipal Corporation; and (v) Warangal Municipal Corporation (a) to scrutinize and issue No Objection Certificate under Section-13 of A.P. Fire Service Act, 1999 for all nonhigh rise buildings, and (b) to conduct inspections and periodic safety of hazardous premises to ensure fire safety compliance to the National Building Code of India, 2005. The Director General, A.P. State Disaster Response and Fire Services, Hyderabad was therefore, requested to delegate the power to the above Municipal Corporations under intimation to Government i.e. Home and MA & UD Department.
- In pursuance of Government instructions as above and in exercise of the powers vested in the 4) various sections of A.P. Fire Service Act, 1999, the powers to ensure Fire and life safety in all non-high rise buildings i.e. less than 18.0 Meters for Residential Buildings and less than 15.0 Meters for other occupancies (Viz. Educational, Institutional, Assembly, Business, Mercantile, Industrial, Storage and Hazardous premises as classified in clause 3.1 part 4 of National Building Code, 2005) are delegated to the commissioners of (i) Greater Hyderabad Municipal Corporation, (ii) Greater Visakhapatnam Municipal Corporation, (iii) Vijayawada Municipal Corporation, (iv) Tirupathi Municipal Corporation, and (v) Warangal Municipal Corporation in their jurisdiction.
- The Commissioners of Municipal Corporations are requested to utilize the Services of the Officers of Fire Prevention Wing while exercising these powers and ensure Fire and Life Safety in all non-high Rise Buildings.

- Fixed and first-aid Fire Fighting equipment, alarm etc shall be tested and maintained regularly as per applicable standards and Fire-Drills conducted quarterly for first two years and half yearly after two Years. Also expired equipment should be replaced immediately.
- No temporary structure such as tents or with thatched construction should be allowed for educational institutions.
- Emergency power generator etc., and associated equipment should be tested periodically, verified as per NBC, and IS-1646.
- Every room with a capacity of 45 students (for educational building) shall be maintained obstruction free minimum two doorways.
- Every vertical opening between the floors of the building shall be suitably
 enclosed or protected to prevent spread of fire, smoke and fumes from one floor
 to other.
- Evacuation plan at showing exit routes and recommended action plan be displayed at conspicuous locations and shall be exhibited all times, all escape /exit routes shall not be blocked or encroached.
- Fresh NOC would be required for any change in occupancy or additions/ alterations in the building structure as per NBC of India and building bye/laws.
- The Management has to maintain Fire Safety Measures at all times in good working Condition as seen during the inspection.
- Any Loss of life or property due to Non functioning of Fire Safety Measures and other installations shall be the responsibility of the management/owner.
- All the Occupants must know the correct method of operation of the First Aid Fire Fighting System installed.
- All Security personnel shall be trained to operate the Fire Safety Equipment during the Emergency.
- Orders will be issued without any prejudice to take action against the Unauthorized construction if any made.
